## Qeybta VI Habka Ashtakada

Qof kasta oo aaminsan in TriMet ay isaga/iyada u geystay xumaanta dhaqanka takoorka sharci darrada ah, taasoo ku saleysan isirka, midabka, ama asal qaran, wuxuu soo gudbin karaa ashtako kaddib marka uu dhamaystiro iyo marka u soo gudbiyo foomka Ashtakada Qeybta VI ee TriMet.

TriMet waxay baari doontaa ashtakooyinka soo gaaray muddo aan ka badneyn 180 maalin kaddib marka lala kulmay dhacdada. TriMet waxay ka shaqeyn doontaa ashtakooyinka dhamaystiran. Kaddib marka la helo ashtako dhamaystiran, TriMet waxay fiirin doontaa ashtakada si loo ogaado haddii xaajada ay hoos timaado TriMet. Qofka soo ashtakooday wuxuu heli doonaa warqadda aqoonsiga taasoo ogeysiisa haddii TriMet ay baari doonto ashtakada.

Guud ahaan, TriMet waxay dhamaystiri doontaa baarista muddo 90 maalin gudahooda laga bilaabo marka la gaarsiiyo foomka ashtakada dhamaystiran. Haddii loo baahan yahay macluumaad badan si loo xalliyo kiiska, waxaa dhici karto in TriMet la soo xariirto qofka soo ashtakooday. Haddii TriMet aysan cayimin muddo dheer, ashtakoodaha waxaa la siin doonaa toban (10) maalin laga bilaabo taariikhda warqadda lagu codsanaayo macluumaadka loo diray baaraha TriMet ee loo xil saaray kiiska.

Haddii ashtakoodaha uusan la xariirin baaraha TriMet ama uusan helin macluumaadka dheeraadka ah muddada loo baahan yahay gudaheeda, waxaa dhici karto in TriMet xerto kiiska, maamul ahaan. Waxaa kaloo dhici karta in maamul ahaan kiiska la xero haddii qofka soo ashtakooday uusan rabin in uu sii dabagalo kiiska.

Kaddib marka la dhamaystiro baarista, TriMet waxay warqad u diri doontaa ashtakoodaha, taasoo soo koobta natiijada ka soo baxday baarista, sheegta waxa la ogaaday iyo kala tallisa talaabada sixidda ee loo baahan yahay in la qaado sida ka soo baxday baarista. Haddii ashtakoodaha qilaafsan yahay go'aanka TriMet, isaga/iyada wuxuu codsan karaa dib u tixgelin kaddib marka uu codsi qoran u gudbiyo Maamulaha Guud muddo todobo (7) maalin gudaheeda kaddib marka la helo warqadda TriMet, taasoo si tafatiran u sheegta aasaaska dib u tixgelinta. Maamulaha Guud wuxuu ashtakoodaha ogeysiin doonaa go'aankiisa haddii uu ogol yahay ama diidan yahay codsiga dib u tixgelinta muddo 10 maalin gudahooda.
